Fresh Developments in Northeast Asia

A quarter of a century has passed since ERINA began its activities with high hopes for Northeast Asia's abundant potential for development. Despite changes in social systems and rapid economic development, economic disparities have deepened and exchanges have failed to progress in line with expectations in some areas. Regional cooperation continues to be required to ensure the future development of Northeast Asia.

While there are new dimensions in each economy, the countries of the region share some common challenges. Having entered the phase that it calls the "new normal," how will China change its society and move forward with the One Belt, One Road initiative? As Russia pivots toward the Far East, to what extent will it be able to leverage its trump card of priority development zones to boost its international competitiveness? Mongolia is working on rebuilding its economy, while the ROK is attempting to secure stable growth. At its first-ever summit meeting with the U.S., the DPRK committed to denuclearization. Meanwhile, Japan aims to increase its potential growth rate by devoting its energies to people-to-people exchanges. Even greater economic cooperation will be essential to resolving the region's shared challenges, such as the aging population and declining birthrate faced by Japan, China, and the ROK alike, and Russia and Mongolia's dependence on resources, not to mention global climate change. A new dimension that encompasses flows of people and goods could be forthcoming, depending on how the situation unfolds in the DPRK.

ERINA was established as an incorporated foundation in October 1993, with the approval of the then Ministry of International Trade and Industry. The Prime Minister later approved its transition to become a public interest incorporated foundation in September 2010. Our mission is to assist in the formation and development of a Northeast Asian economic zone, thereby contributing to both the regional and international community. As well as tapping into the research exchange network that we have built up over the last 25 years to enhance our international collaborative research, we will continue to promote economic exchange activities with an emphasis on the perspectives of provincial Japan.

Introductory Statement

On the Occasion of Publishing ERINA's Fiscal Year 2018 Annual Report

The primary objectives of ERINA, as outlined in the "Medium-Term Plan 2014-2018", are "enhancing our central position as a base for Northeast Asian research" and "strengthening our role of building bridges between Northeast Asia and local communities". To achieve these, in fiscal year 2018 we centered our efforts and resources on three areas; "the challenges and future prospects for Northeast Asian regional cooperation and analysis of the economies of the nations of Northeast Asian"; "promotion of economic exchanges and local economic revitalization"; and "information center" activities.

Regarding ERINA's operation, although our interest income from basic assets was reduced due to low interest rates reflecting the underlying economic environment, an increase in operating subsidies from Niigata Prefecture and the planned decumulation of specific project funds allowed us to carry out international collaborative research as well as the ERINA 25th Anniversary Project with a budget that was larger than in the previous year by approximately 12.5 million yen. We strived to execute high-quality, effective and efficient business operations in all areas, and worked hard to enhance the capacities of the Research Division and the dissemination of information by the Planning & PR Division. In terms of personnel, we employed nineteen staff, achieving minimal turnover (full-time – increase of 1, part-time – reduction of 2) from the previous year.

In fiscal year 2018 we witnessed new developments on the Korean Peninsula, such as the two historic U.S.-DPRK summit meetings, and the intensification of U.S.-China trade war. With the Northeast Asian region attracting increased attention from the international community, ERINA also delved into the subject at the 2019 Northeast Asia International Conference for Economic Development (NICE) in Niigata, examining changes in the situation on the Korean Peninsula and cooperation in Northeast Asia. In the context of Northeast Asia's economic integration and cooperation, we also conducted research on the effects of the trade friction between the U.S. and China.

The following is a brief description of the project results for the three areas. First, in relation to "the challenges and future prospects for Northeast Asian regional cooperation", we concentrated on foreseeable areas of cooperation between countries, among other things: regional economic integration; responses to changes in the situation on the Korean Peninsula; logistics and infrastructure development; promotion of trade and investment; energy security and cooperation; and measures to mitigate global warming. We examined the state of progress of cooperation in these areas, the challenges faced, potential ways and means for resolution, and the possible future scenarios. In addition, for the "economic analysis of each Northeast Asian nation", we continued to collect and dissect information on basic subjects such as macroeconomic trends and recent economic policy developments in each Northeast Asian country and conducted analysis on key issues specific to each economy.

Next, in the "promotion of economic exchanges and local economic development", we participated in international conferences, trade fairs, and business meetings in China, the ROK, and Russia, further strengthened our human and organizational network, undertook the collection and dissemination of businesses information, provided support to various companies, and continued to collaborate in technical cooperation in Mongolia. With the growing need for the use of foreign workers, the International Students' Job Fair was staged to support the overseas expansion and globalization of local companies.

As for operations in the "information center", in addition to our annual activities, we published a commemorative periodical and staged a celebratory symposium in honor of ERINA's 25th Anniversary. In preparation for medium-term planning to commence the following year and cover the next 5 years, we formulated the 4th Medium-Term Plan 2019-2023. For the first time, we staged "NICE" and "Japan-Russia Energy and Environment Dialogue" simultaneously. By combining economic development and integration in Northeast Asia and energy and environmental cooperation into one integral event, the meeting shed clear light on the relevant issues of national policy and multilateral cooperation going forward.

Following the above outline of project operations for fiscal year 2018, the annual report provides detailed explanation on the outcomes of each individual field and includes financial data. In light of the objectives set forth in the Medium-Term Plan and fiscal year plan, the section on individual project reports brings together an evaluation by staff in charge from the perspectives of the appropriateness of the targets set, the validity of the outcomes and the efficiency of inputs, which was based on a critical analysis and examination by the members of the Internal Evaluation Committee.

A. The Challenges and Future Prospects for Northeast Asian Regional Cooperation

To contribute to policy review and to promote the expansion and deepening of intraregional cooperation in Northeast Asia, we analyzed and examined various activities in major cooperation fields, the progress of international projects, the future challenges to be faced and their potential solutions, and the future scenarios.

1. Regional Cooperation for Regional Integration in Northeast Asia

Begun in fiscal year 2017 with the aim to deepening research on "Regional Cooperation for Regional Integration in Northeast Asia", we staged international workshops attended by experts covering a broad range of fields and prepared for the publication of an English book in fiscal year 2019.

To respond to the new international landscape, we hosted "Changes in the Situation on the Korean Peninsula and Cooperation in Northeast Asia", an international workshop attended by experts from relevant countries.

In addition, we launched a new framework for international collaborative research with the Economics School of Jilin University, and conducted research presentations and discussions involving researchers from both countries.



Turbulent period in the Northeast Asian region and ERINA

ERINA was established in October of 1993, the year which followed the collapse of the former Soviet Union and subsequent end of the Cold War and saw many former Eastern bloc countries commence the shift from a socialist economy to a market economy. Even in Northeast Asia, where China was already pushing for a gradual transition to a "socialist market economy" under the policy of open reforms, Russia and Mongolia embarked on a radical market economy called "shock therapy." Although the DPRK did not directly aim at a clear market economy, the idea of a possible North-South integration emerged on the Korean Peninsula, similar to the one witnessed previously between West and East Germany. Economic exchange between countries via open international trade and capital transactions had expanded, and it was anticipated that a regional "economic zone" would be formed. It was believed that the complementary relationship between economies within the zone, derived from the combination of natural resources from the Far East of Russia and Mongolia, the labor force of northeast China and the DPRK, in addition to Japan and the ROK's capital and technology, would result in a win-win situation for all parties. In the context of these times, ERINA was founded on a grand vision of the formation and development of the Japan Sea Rim (Northeast Asia) Economic Zone, as a think-tank that promotes economic exchange between Japan and the region by conducting research and study on the economy of each nation within the region.

During these last 25 years, ERINA has been a base for research, economic exchange and the dissemination of information on the Northeast Asian economy and has consolidated its core foundation over time. Especially, its vast, domestic and international human network constructed through mutual exchange in international conferences and joint research is widely recognized, and ERINA is now a representative institution of Northeast Asian Economic Studies. Further recognition for ERINA has come in response to its extremely effective approach in analyzing the Northeast Asia region not only in terms of individual nations, specific fields and bilateral relationships between Japan and its northeast Asian neighbors, but also as a comprehensive, multilateral interdependence area, and the position of Northeast Asia in the global economy.

Since 2004, ERINA has released a medium-term plan spanning each five years to specify our activity aims and to enhance the effectiveness of our business. ERINA has acted upon the 1st Medium-term Plan 2004-2008, with its roles organized into "Information Center", "Research Center" and "Economic Exchange Support Center", and with the setting out of the three basic directions of "promotion of multilateral and multi-regional projects", "research and policy proposals" and "interregional exchange and regional economic promotion". Regarding this fundamental framework relating to ERINA's purposes and tasks, the ERINA 2nd Medium-Term Plan 2009-2013 and 3rd Medium-Term Plan 2014-2018 have been continued and are currently being maintained.

However, in the meantime, the Northeast Asian region has changed significantly. First, Japan has fallen into a secular stagnation referred to as "The Lost 20 Years", with the nation suffering from an accumulation of declining birthrate, aging population and government debt. Consequently, the revitalization of the local economy has become an ever-pressing issue. Secondly, China has achieved remarkable economic development in becoming the world's second largest economic power, taking over Japan in 2010, has advanced the development of a wide-area economic zone initiative "One Belt One Road (B&R)", and has enhanced its presence throughout Asia and the world. The third is that the ROK has labored on structural reforms since the financial crisis of 1997-98, with growth centered on its high-tech sector, but it now faces growing economic inequality, a declining birthrate and aging population. Fourth, Russia and Mongolia have experienced rapid growth on the back of rising resource prices, however, their economic instability resulting from resource dependence is somewhat conspicuous. Russia in addition, has faced economic sanctions imposed by the West over the annexation of the Crimean Peninsula and its intervention into the dispute of eastern Ukraine. The fifth is that the DPRK conducted nuclear tests and developed ballistic missiles, which first threatened the safety and peace of Northeast Asia in the late 2000s. However, following the historic DPRK-U.S. summit held in June 2018, a more positive outcome is expected. Sixth, the U.S.-China trade war that began in the same year under the watch of U.S. President Donald Trump has expanded into an intense competition for economic, technological, political and military supremacy, with its influences leading to further uncertainty in trade, the economies and political environment within Northeast Asia.

Though Northeast Asia is expected to experience ongoing steady growth and development, the above-mentioned changes in the area and beyond suggest a growing downward risk in the region. In China, for example, we see signs of financial instability, with income inequality,

regional disparities and environmental issues becoming more consequential. As its trade and economic war with the U.S. intensifies, China faces the risk of a significant decline in growth rates. On the other hand, it has been pointed out that the construction of "One Belt One Road (B&R)" has aggravated the debt predicaments of other countries. Although military tensions between the DPRK and U.S. have eased, the two nations express markedly different perceptions over the issue of Denuclearization, therefore, one cannot completely rule out armed conflict on the Korean Peninsula. Furthermore, the discord between Russia and Western Europe and the U.S. may become aggravated should any further rise in tensions between the two sides occur.

On the flip side, the region faces upward growth opportunities at the same time. Assuming that China continues to move forward with structural reforms of the supply side to cope with domestic financial problems, environmental issues and disparity troubles, and to manage its trade war and battle for economic and high-tech supremacy with the U.S. in an international, cooperative manner, sustainable growth and development can be expected. Moreover, if the "One Belt One Road (B&R)" initiative can in fact enhance the economic benefits of participating countries, it will contribute significantly to the development of the Northeast Asia region. If the DPRK is to be denuclearized, and the necessary economic reform and opening routes are taken to join the regional economic cooperation of Northeast Asia as a member of the international community, the entire region will begin to move dynamically, and economic integration may progress significantly. Or, if Russia returns to a route of international collaboration and the economic cooperation between Russia and Japan is strengthened sufficiently, economic interdependence between Russia and Japan, China and the ROK may develop considerably. That in turn would potentially lead to a peace treaty between Russia and Japan and the return of the Northern Territories.

In this way, Northeast Asia is an area that has the capacity for both downward risk and upward opportunities, and in that sense, it is a tumultuous region. As ERINA, we shall strive to further deepen our activities as an international base for research, economic exchange and the dissemination of information in order to tackle the new challenges encountered in the Northeast Asian regional economy during this period of turbulence. In particular, ERINA will pay close attention to the changes in each country's economy and interdependence which are brought about by environmental changes in the domestic and international surrounds of the Northeast Asian region, promote comprehensive economic analysis of the whole region as well as multilateral cooperation and regional cooperation, and enhance the function of effective information dissemination. At the same time, we shall strengthen cooperation and exchange with think-tanks, international organizations and universities in and outside of Northeast Asia. ERINA will further consolidate the role of our flagship annual event, Northeast Asia International Conference for Economic Development (NICE) in Niigata, moreover, we will contribute in various ways to draft policy proposals for central and local governments and international organizations of relevant nations related to the strategic direction that the Northeast Asian region should pursue. Aiming at organizational management in high public interest and efficiency, we will meet the expectations of numerous officials including sponsoring municipalities and supporting members.

Based on the above viewpoints, ERINA has outlined the basic directions of the 4th Medium-Term Plan 2019-2023. Organically linking our three core activities of research, economic exchange support and the dissemination of information, we strive to contribute to the peace, stability and prosperity of the Northeast Asian region; to strengthen our role as a bridge between Northeast Asian countries and Japan, and particularly its local communities; to deepen the inclusiveness and advancement of research on Northeast Asian economies; to connect our knowledge gained from economic exchange and field-oriented research with policy-making; to disseminate high-quality information effectively. And through all the above, as the world's one-of-a-kind think-and-do-tank, with a target to strengthen its nature as a base in Japan and overseas, we have set this Medium-Term Plan.

[Overview of the 4th Medium-Term Plan 2019-2023]

We shall strengthen our central position base as a think-and-do-tank in Northeast Asia through the organic integration of three activities; research, economic-exchange support, and dissemination of information. We shall strive to develop international human resources and enhance intellectual infrastructure and expanded human networks via the strengthening of multilateral industrial-governmental-academia cooperation. Research will contribute to and expand the availability of resources for experts and policymakers. The provision of economic exchange support aims to promote local economies in Japan for local businesses, municipalities and the economic community. Sophistication of information dissemination function will be sought to benefit global and local communities. Evaluating the achievements of ERINA projects and the Medium-Term Plans, we shall pursue efficient organizational operations and high-public interest.

1. Strengthen its central position as a think-and-do-tank in Northeast Asia

(1) Reinforce ERINA's core function as a base for multilateral industry-government-academia cooperation

We shall contribute to the peace, stability and prosperity of the region as a base for promoting multilateral industrial-government-academia cooperation in Northeast Asia by leveraging the cooperative relationship between domestic and international public and private institutions cultivated through conventional activities. To this end:

- We shall continue to host high-quality international conferences, symposiums, and seminars in which a wide range of officials in the field of Northeast Asian economic cooperation can participate, including the Northeast Asia International Conference for Economic Development (NICE) in Niigata, and shall aim to create new value through mutual intellectual exchange.
- ERINA shall enhance its primary role in active cooperation with various international organizations that promote regional cooperation in Northeast Asia, such as the United Nations Economic and Social Committee for the Asia Pacific Region (ESCAP), Asian Development Bank (ADB), and the Greater Tumen Initiative (GTI).
- We shall conduct not only international symposiums, seminars, and workshops hosted or sponsored by ERINA, but also other
 high-quality events in cooperation with domestic and overseas institutions with whom we have exchange agreements in place
 and additional research and educational institutions.
- We shall support industry-government-academia collaborative economic exchange projects conducted by sponsoring
 organizations or institutions signed to exchange agreements, and actively mediate on the cooperation of these projects.

(2) Organic integration of research, economic exchange support and the dissemination of information ¹

By organically integrating the three activities of research, economic exchange support and the dissemination of information, we shall utilize the strengths of ERINA and enhance its central function as a think-and-do-tank. To this end:

 The Research Division shall not only conduct pure economic analysis but also strengthen cooperation with the Economic Exchange Support Division reflecting the movement of the field in order to conduct analysis that leads to effective policy-making.

The "International Collaborative Research Center" was established in 2011 in ERINA with the aim of enhancing the World Only-One Research Institute in the Northeast Asian economic and social field. Since then, the entire ERINA activities have become an international collaborative research center, and in the 4 Medium-Term Plan, the center will be dissolved progressively.

The 4th Medium-Term Plan 2019-2023

- In order to implement more effective exchange support projects, the Economic Exchange Support Division shall collaborate with the Research Division to propose new study and research methods and utilize the results.
- The Information Dissemination Division shall effectively disseminate high-quality information obtained through research
 and economic exchange support in an effective manner. At the same time, they shall propose useful research and analysis
 and information gathering techniques to the Research and Economic Exchange Support Division, so that ERINA can further
 enhance its primary role.

(3) Develop international human resources and enhance the intellectual infrastructure for research and economic exchange

We shall strive to foster international human resources and intellectual infrastructure to support economic development and economic exchange in Northeast Asia as it faces a tumultuous period.

- We shall seek an improvement in the quality of Northeast Asian economic analysis conducted by Japanese and overseas
 researchers through the use of a collaborative researcher system and invited overseas researcher system, and at the same time,
 strive to foster international human resources and the promotion of intellectual foundations.
- We shall make available to the public the results of research and economic exchange support through lectures and
 presentations at various symposiums and seminars conducted by various

governmental agencies and economic organizations, etc.

- We shall systematically create a database of various economic and business information related to Northeast Asia and publish
 it via the Internet and other media.
- Assuming the participation of the DPRK in the international community, we shall implement a capacity building project to promote the necessary intellectual infrastructure.
- We shall endeavor to develop the next generation of international human resources by exploring the possibilities of
 implementing training programs in the form of accepting human resources from local governments, private companies,
 educational institutions, and research institutes, moreover, accepting students on a temporary basis via internship and
 providing lessons and/or lectures at educational institutions.

2. Deepen our research and contribution to policy-making

(1) Deepen our comprehensive and advanced research of Northeast Asia

Deepen our comprehensive and advanced economic analysis across the region, focusing on the transformation of economies and interdependence of the Northeast Asian countries.

- We shall publicize the results of research studies in academic journals and technical books and further our creative and academic contributions to specialized fields.
- We shall identify key issues for economic growth, regional economic integration and the expansion of regional cooperation (economic restructuring, economic partnership, international connectivity, energy cooperation and global warming countermeasures). We shall generate research themes that emphasize multilateral, bilateral and regional relationships. From the perspective of Northeast Asia in the global economy, we shall also conduct comparative analysis and analysis on relations of interdependence between Northeast Asia and other regions.
- We shall aim at understanding the research needs of local communities and policy makers and create a framework that can
 flexibly respond to them. In order to achieve this, we shall deepen cooperation with not only research studies by ERINA staffs,
 but also cooperation with external human resources (researchers in various fields, including not only economics but also
 political science, sociology and natural sciences).

(2) Contribute to society through efficient research

In order to achieve maximum results under limited resources, we shall strive for efficient research by utilizing external human resources and external funds and return the results to society.

- We shall promote collaborative research with researchers and research institutes in Japan and abroad while utilizing the various systems such as research exchange agreements, joint research fellows and invited overseas researchers. We shall actively participate in high-priority collaborative research conducted by external research institutes.
- We shall strive to acquire external research funds such as Grants-in-Aid for scientific research, research contracts on topics closely related to ERINA's Research. In particular, we shall emphasize the importance of research contracts for not only the use of external funds, but also as a means to grasp research needs.
- We shall make concerted efforts to support the development of researchers by utilizing various study and training programs and overseas research systems.
- We shall explore the possibility of creating a human resources exchange program with higher education institutions and research institutes, etc.
- To make the best use of the research results in society, we shall publish them selecting appropriate media and opportunities for each target such as the industry, policy planning officials, the youth, and mass media.

(3) Establish policy-making functions directed at each country's governments (central and local) and international organizations

In tune with our position as a think-and-do-tank, we shall aim at contributing to policy-making in the Northeast Asia region as a research institution.

- We shall conduct research for not only pure economic analysis, but also for obtaining policy implications for all countries and regions in Northeast Asia.
- We shall strive to contribute to realistic policy-making based on research and economic exchange on the strategic direction of Northeast Asia.
- We shall be actively involved in various phases of the policy formulation process so as to understand research needs and to reflect these results into the policy planning of national governments (central and regional) and international organizations.

3. Provide economic exchange support and promote local economies in Japan

(1) Collect and provide high-quality information to promote economic exchange

We shall collect high-quality business-related information covering a wide range of fields and the latest economic and social trends in Northeast Asia and present them in a user-friendly format.

- In collecting a wide range of high-quality information, we shall strive to expand and deepen our domestic and overseas organizational and human networks as a tool for information collection.
- We shall selectively participate in events such as domestic and overseas conferences and trade fairs and encourage related companies and organizations to do likewise.
- In addition to "visualizing" the basic and business-related information of Northeast Asia (economic situation, trade, fairs, business meetings, etc.) and accumulating them within ERINA, we shall provide them in an effective and immediate manner using electronic media and other methods.
- We shall hold business seminars relevant to current events in Northeast Asia and corporate needs and assist with seminars
 conducted by other organizations, and actively publicize and disseminate the information collected.

(2) Support the advancement of regional cooperation leveraged by association with sponsoring municipalities and private organizations

As a do-tank, we actively support exchange projects and events in Northeast Asia hosted by sponsoring municipalities and private organization to contribute to the promotion of regional exchange.

- We shall make efforts to understand the needs of local cooperation by carrying out questionnaire-based surveys etc. and propose support measures and conduct project cooperation.
- To improve the effectiveness of cooperative activities, we shall strengthen ties with economic-related organizations in

sponsoring municipalities by providing support and cooperation.

• We shall reinforce cooperation with sponsoring municipalities and private organizations in view of human resources exchange for enhancing the level of economic exchange in the Northeast Asia region.

(3) Promote local economies through overseas expansion of private companies and local business exchange

As a do-tank in the Northeast Asia region, we shall endeavor to create business opportunities that are easy for each country's private companies to enter into with each other and contribute to the promotion of local economy through support activities for business matching and overseas expansion of companies.

- We shall aim to establish a mutually complementary system that can provide an optimal support menu for companies by sharing information and roles with relevant organizations in Japan and overseas.
- Accurately grasping the needs of companies and businesses in Japan and overseas, we shall arrange inspections of Japanese
 companies and business meetings for delegations and companies from overseas as well as to dispatch and attend trade fairs,
 business meetings, industrial inspections (etc.) in foreign countries.
- Along with continuing to hold the "International Students' Job Fair" to support the overseas expansion and globalization of
 companies and provide opportunities for employment for international students in Japan, we shall support initiatives aimed at
 the utilization of overseas human resources conducted by other organizations based on the knowledge and know-how gained
 through this project.²

4. Sophistication of information dissemination function

(1) Effective dissemination of collected information

We shall further enrich the dissemination of information via our publications, including the "ERINA Report (Plus)" and website, and effectively disseminate information to both local and international communities.

- We shall continuously disseminate unique and high-quality information on Northeast Asian economies and endeavor to strengthen the dissemination of ERINA staff's research papers, books and advertisements in English.
- We shall strengthen the dissemination of information for the general public through mass media.
- While actively utilizing the various existing information disclosure tools that provide information, we shall flexibly incorporate new Information and Communication Technology (ICT) and Social Networking Services (SNS) such as website, blogs and e-mail newsletters, etc. and strive to disseminate information in an effective manner.

(2) Plan attractive international conferences, symposiums and seminars

In order to enhance the attractiveness of international conferences, symposiums and various seminars, we shall strive to enrich the contents deepening our cooperation among each division within ERINA and with external related organizations as well as constantly reviewing the objectives and roles of these events.

- We shall endeavor to introduce an innovative management method of international conferences that utilizes ICT, such as paperless meetings and internet conferences, etc.
- We shall endeavor to organize attractive symposiums and seminars that provoke a wide range of interest by setting appropriate themes in response to changes in society.

(3) Expansion and competent use of domestic and global human networks

We shall aim for the effective utilization of the human networks related to research and economic exchange in Japan and overseas via a process of thorough management and expansion.

² Launched in 2005, the "International Students' Job Fair" is a business program unique to ERINA that provides international students in Niigata Prefecture with opportunities for interviews aimed at employment within local companies and is expected to contribute to the overseas development of companies.

- We shall manage and expand our human networks in Japan and overseas as assets of great importance via collaborative researchers, invited overseas researchers, economic exchange officials, international conference participants, and shall work hard to ensure the effective utilization of each.
- Through our human networks in Japan and overseas, we shall spread the research and economic exchange results of ERINA
 around Japan and to the world.
- Enhance the ability to disseminate information by sending various kinds of information utilizing the human networks in Japan and overseas.

5. Pursue efficient organizational management and high public interest

(1) Ensure projects of efficiency and high public interest

We shall fully comply with the laws and regulations required of a public interest incorporated foundation and fulfill our sense of accountability. In addition, to achieve maximum results under limited resources, ERINA shall increase the efficiency of project implementation by focusing its activities on areas of need and potential.

- Under the governance of the Council and the Board of Trustees, we shall appropriately revise ERINA's articles of incorporation and regulations as necessary to respond flexibly to new public interest needs.
- We shall publish the results of each project of research and economic exchange support and return them to society in various ways.
- As a highly distinctive research institution that advocates itself as a think-and-do-tank position, we shall work diligently to
 enhance cooperation among the divisions within ERINA, and to enhance project outcomes by organically integrating the three
 activities of research, economic exchange support and information dissemination.

(2) Create a system to support the education of international human resources and improve intellectual infrastructure and human networks

In addition to nurturing ERINA staff as international human resources, we shall endeavor to create a mechanism to improve human networks and intellectual infrastructure, our greatest assets, via research and study, international symposiums, seminars, and the results of economic exchange support.

- We shall aid the development of ERINA staff through their participation in study and training projects, personnel evaluation systems and personnel exchange programs with external institutions (research institutes, local government, private organizations, etc.).
- We shall work diligently to protect the intellectual assets of ERINA by placing an Intellectual Property Officer within ERINA
 and advance the data-making capabilities of the intellectual infrastructure and human networks across each part of the
 organization.

(3) Implementation of effective evaluation systems for projects and personnel

Evaluating qualitatively and quantitatively the goals of projects and personnel in each fiscal year based on the Medium-Term Plan and their results and effects, we shall utilize them to formulate new projects and personnel plans.

- Through annual project evaluations, we shall verify the appropriateness, effectiveness, efficiency, and achievement of each
 policy in the Medium-Term Plan. We shall also report the results to the Board of Trustees and the Board of Directors and
 utilize the results for the formulation and implementation of the projects planned thereafter.
- Introducing the new personnel evaluation system, we shall contribute to the development of human resources in ERINA and utilize it to conduct personnel planning in the years to come.




