In this document we refer to the People's Republic of China as China, the Democratic People's Republic of Korea as the DPRK, the Republic of Korea as the ROK and the Russian Federation as Russia. In addition, the sea referred to in this publication as the Japan Sea is called the East Sea in the DPRK and the ROK.



Fresh Developments in Northeast Asia

A quarter of a century has passed since ERINA began its activities with high hopes for Northeast Asia's abundant potential for development. Despite changes in social systems and rapid economic development, economic disparities have deepened and exchanges have failed to progress in line with expectations in some areas. Regional cooperation continues to be required to ensure the future development of Northeast Asia.

While there are new dimensions in each economy, the countries of the region share some common challenges. Having entered the phase that it calls the "new normal," how will China change its society and move forward with the One Belt, One Road initiative? As Russia pivots toward the Far East, to what extent will it be able to leverage its trump card of priority development zones to boost its international competitiveness? Mongolia is working on rebuilding its economy, while the ROK is attempting to secure stable growth. At its first-ever summit meeting with the U.S., the DPRK committed to denuclearization. Meanwhile, Japan aims to increase its potential growth rate by devoting its energies to people-to-people exchanges. Even greater economic cooperation will be essential to resolving the region's shared challenges, such as the aging population and declining birthrate faced by Japan, China, and the ROK alike, and Russia and Mongolia's dependence on resources, not to mention global climate change. A new dimension that encompasses flows of people and goods could be forthcoming, depending on how the situation unfolds in the DPRK.

ERINA was established as an incorporated foundation in October 1993, with the approval of the then Ministry of International Trade and Industry. The Prime Minister later approved its transition to become a public interest incorporated foundation in September 2010. Our mission is to assist in the formation and development of a Northeast Asian economic zone, thereby contributing to both the regional and international community. As well as tapping into the research exchange network that we have built up over the last 25 years to enhance our international collaborative research, we will continue to promote economic exchange activities with an emphasis on the perspectives of provincial Japan.

On the Occasion of Publishing ERINA's Fiscal Year 2019 Annual Report

The fiscal year 2019 was the first year of the 4th "Medium-Term Plan 2019–2023". In this fiscal year, we pursued the basic directions of ERINA identified in the Medium-Term Plan, i.e., "Strengthening of its position as a think-and-do-tank in Northeast Asia", "Deepening of our research and contribution to policy-making", "Promotion of economic exchanges and local economic development" and "Sophistication of the information dissemination function". For this purpose, we focused our activities on three areas: "Research", "Economic exchanges and local economic revitalization" and "Information dissemination".

Regarding ERINA's business operations, even though our interest income on its basic assets decreased due to low-interest rates reflecting the underlying economic condition, an increase in operating subsidies from Niigata Prefecture and the planned use of specific project funds allowed us to carry out international collaborative research. However, operational spending decreased by approximately 12.08 million yen compared to the previous fiscal year due to the postponement of international conferences planned for February- March, because of the spread of the novel coronavirus (COVID-19) at the end of the fiscal year. Despite the downscaling of operations, we continued to make efforts at implementing high-quality, effective, and efficient projects in the areas of research and economic exchanges, as well as working diligently to enhance information dissemination activity. In terms of personnel, we maintained a total of 18 staff members (with a decrease of 2 permanent staff and an increase of 1 non-permanent staff), practically the same size as the previous year.

Reviewing the Northeast Asian situation in fiscal year 2019, the U.S.-DPRK denuclearization talks over the Korean Peninsula did not make progress; still, the U.S. and Chinese governments have reached "a first-phase agreement" in trade talks on pending issues stemming from the trade war that began the previous year, avoiding further deterioration of the bilateral trade relationship. Although Japan-China relations continued to improve from the previous year, Japan-ROK relations have fallen to the worst level since 1965 when their diplomatic relations were normalized. Economic cooperation between Japan and Russia has advanced to some extent in line with the Eight-Point Cooperation Plan.

As the global influence of China's growing economy continues to increase, ERINA was planning to address the issue of China's economic growth and Northeast Asian economic cooperation at the "2020 Northeast Asia International Conference for Economic Development (NICE) in Niigata". However, at the end of the fiscal year, the spread of COVID-19 restricted, or led to the postponement of, several projects such as NICE, international joint research and economic exchanges.

Despite these circumstances, we were able to implement our projects in the three areas as follows.

First, with regard to "Research", we investigated the state of progress of cooperation, the future challenges, and methods for resolution, and the possible future scenarios in the areas where the potential for cooperation is expected to be significant, including: the regional response to the U.S.-China trade war; regional economic cooperation toward the changes in the situation on the Korean Peninsula; logistics and infrastructure; promotion of trade and investment; and energy and global-warming countermeasures. In addition, we continued to monitor and analyze basic subjects including macroeconomic trends and economic policy implementation in each country and conducted research on key issues specific to each economy.

Next, with regard to "Economic exchanges and local economic revitalization", we participated in international conferences, trade fairs and business meetings in China, the ROK and Russia, enhanced our human and institutional network, undertook the collection and dissemination of business information, provided support for various firms, and collaborated in technical cooperation in Mongolia. With the increasing need for the use of foreign workers in Japan, we staged the "International Students' Job Fair" to support the overseas expansion and globalization of local companies.

At last, for "Information dissemination", we undertook the gathering and provision of information, the publication of "ERINA REPORT (PLUS)" and the "ERINA Northeast Asia Research Series", and support for international collaborative research. We strove to strengthen the network between ERINA and researchers, policymakers and business-related experts in Japan and the Northeast Asian region.

The brief overview of project outcomes for the fiscal year 2019 is outlined above; however, as previously mentioned, several projects were postponed or cancelled at the end of the year. This fiscal year's annual report contains a detailed explanation of outcomes for individual projects in each field, as well as financial data. Moreover, in the light of the targets set for each project in the Medium-Term Plan and the fiscal year plan, the section on individual project reports brings together the results based on an evaluation made by staff in charge from the perspectives of the appropriateness of the targets set, the validity of the outcomes and the efficiency of inputs, as well as critical analysis and investigation made by the members of the Internal Evaluation Committee.

A. Research

To contribute to policy review and to promote the expansion and deepening of intraregional cooperation in Northeast Asia, we analyzed and examined various activities in major cooperation fields, the progress of international projects, the future challenges to be faced and their potential solutions, and the future scenarios.

1. The Challenges and Future Prospects for Northeast Asian Regional Cooperation

Regional Cooperation for Regional Integration in Northeast Asia

Aimed at examining the impacts of the situation on the Korean Peninsula, which has changed significantly since the first-ever U.S.-DPRK summit meeting in June 2018, we conducted an international joint research project on economic cooperation in Northeast Asia from the perspective of each country in the region. As part of this effort, we held private international workshops and open seminars in Tokyo led by participants in the joint research. The results of the joint research project will be published in an English book in fiscal year 2020. In connection with this theme, we also hosted the "Northeast Asia Regional Cooperation Symposium" in Niigata (detailed below in "Regional Seminar" of 3 c (ii.) – C Information Dissemination).

Furthermore, we set the theme of the next international joint research as "China's Economic Transformation and Northeast Asia", and the participants were decided. Due to the impact of the COVID-19 infection, we were forced to review the schedule, but plan to advance research activities once the spread of the infection is confirmed in fiscal year 2020.

2. Analysis of the Economies of the Nations of Northeast Asia

The Economic Development of the Far Eastern Region of Russia

We purchased books, newspapers, magazines, newsletters, and other materials which focus on the economy of Northeast Asia, accepted and registered donated books, and made them available to willing readers.

With the progress of electronic data conversion of books and the fact the publication in paper of some books will be discontinued in the future, we will continue to investigate the situation and reconsider our plan to purchase continuing books for the next year and beyond. We will encourage the effective use of books, which are invaluable assets, both inside and outside the institute.

b Dissemination of Information Using ICT

Using our website and e-mail magazine, we disseminated information about the economies of Northeast Asia and the activities of ERINA. The number of visitors to the website increased to an average of 12,996 per month (10,159 in FY2018). Our E-mail magazine "North East Asia Watch" readership was 1,643 copies (1,682 copies in FY2018).

With the aim of increasing the number of visits to and time spent on our website, we will improve the ability to disseminate information in conjunction with SNS, and build a user-friendly website that makes it easy for viewers to access the information they need.

To introduce ERINA's business, among others, we updated the contents of business in the brochure and prepared it in five languages. In addition, ERINA Annual Report compiled business and financial reports for the fiscal year 2018 and was published on 20 August 2019 (900 copies).

With regards to the accomplishments of each researcher in the Annual Report, we utilize *researchmap* (database-type list of researchers), aim for simple, well-listed editing, and make efforts to save on time and labor. We will work at creating pamphlets that are easy to understand according to the target audience and application.

d General Media Publicity

To raise interest in Northeast Asia across a diverse spectrum of society, largely within Niigata Prefecture, we contributed the "ERINA Letter" and "Reading Northeast Asia" to the *Japan Sea Information Line* of the *Niigata Nippo* newspaper, and "Ringoku Jocho (Neighboring Countries' Sentiments)" to the *Tottoki Guide*, the free information booklet of Toki Messe. The monthly ERINA Letter was published once monthly (a total of 12 times), Reading Northeast Asia twice in total, and Ringoku Jocho six times, on a bimonthly basis. Press releases on seminars and events, as well as the giving of interviews were also carried out. In addition, press releases of seminars and event information and interviews were also held.

Subsequent Challenges and Directions at the Internal Evaluation Committee

We will continue to disseminate information about Northeast Asia and ERINA activities to the public and strive to increase the number of people interested in our work.




