In his keynote address, Mr. Akashi commented on the remarkable coincidence that 1993, the year of ERINA's establishment, was also the year in which the United Nations Transitional Authority in Cambodia (UNTAC), a major UN peacekeeping operation, opened the door to peace and democracy in Cambodia. Noting Northeast Asia's complex history and present, he expressed the hope that trade and investment in the region would intensify in the future and that human resource development and interpersonal exchange would take place.

The panel discussion featured two rounds: the first was focused on the current state of the Northeast Asian economy and the challenges that it faces, while the second addressed prospects and expectations regarding future international economic cooperation. Panelists discussed the topics the perspectives of specialist fields (international economics, economic cooperation with Russia, regional economic exchange, and the perspectives of Niigata Prefecture and of ERINA).

ERINA intends to pursue its activities as an international hub for Northeast Asian economic research in even greater depth, while responding flexibly to the changing face of Northeast Asia. We would be more than delighted if the project to mark the 25th anniversary of our establishment proved to be a catalyst for further strengthening partnership and exchange with relevant institutions, both within Northeast Asia and elsewhere.
